## ANNOUNCEMENT ON KEY OPERATING DATA

This announcement is made based on the operating data for April 2024 of the Group to be published on the Shanghai Stock Exchange, and pursuant to Rules 13.09 and 13.10B of the Listing Rules and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The relevant key operating data was calculated based on the internal statistics of the Group, which may differ from the data disclosed in the relevant periodic reports. This announcement is made based on the operating data for April 2024 of China Southern Airlines Company Limited (the "Company") and its subsidiaries (collectively, the "Group") to be published on the Shanghai Stock Exchange, and pursuant to Rules 13.09 and 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

In April 2024, passenger capacity (measured by available seat kilometres ("ASK")) of the Group increased by 9.52% as compared with the same period last year (a year-on-year ("YoY") basis), of which, the passenger capacity for domestic routes decreased by 5.59%, and the passenger capacity for regional routes and international routes increased by 31.29% and 120.17%, respectively, as compared with the same period last year. Compared with the same period last year, passenger traffic (measured by revenue passenger kilometres ("RPK")) increased by 19.79%, of which, passenger traffic for domestic routes, regional routes and international routes increased by 3.12%, 42.20% and 143.80%, respectively, as compared with the same period last year. The passenger load factor was 83.08%, representing an increase of 7.12 percentage points as compared with the same period last year, of which, the passenger load factor for domestic routes, regional routes and international routes increased by 7.03, 6.00 and 8.05 percentage points, respectively.

In terms of cargo operations, in April 2024, cargo capacity (measured by available tonne kilometers ("ATK") - Cargo and Mail) increased by 8.84% as compared with the same period last year. Cargo and mail traffic (measured by revenue tonne kilometres ("RTK") - Cargo and Mail) increased by 23.47% as compared with the same period last year. The cargo and mail load factor was 55.10%, representing an increase of 6.53 percentage points as compared with the same period last year.

In April 2024, the Group has newly launched the following major routes: Chongqing – Kashgar – Yining – Kashgar – Chongqing, Chongqing – Korla – Chongqing (each being three flights a week).

In April 2024, the Group introduced three aircrafts (including one B737MAX aircraft and two A321NEO aircrafts), and disposed of nine aircrafts (including one A321 aircraft, one A320 aircraft, three A330-200 aircrafts and four B737-700 aircrafts). As of the end of April 2024, the Group operated a fleet of 911 commercial aircrafts as set out below:
