This announcement is made based on the operating data for December 2024 of the Group to be published on the Shanghai Stock Exchange, and pursuant to Rules 13.09 and 13.10B of the Listing Rules and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The relevant key operating data was calculated based on the internal statistics of the Group, which may differ from the data disclosed in the relevant periodic reports. This announcement is made based on the operating data for December 2024 of China Southern Airlines Company Limited (the "**Company**") and its subsidiaries (collectively, the "**Group**") to be published on the Shanghai Stock Exchange, and pursuant to Rules 13.09 and 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "**Listing Rules**") and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

In December 2024, passenger capacity (measured by available seat kilometres ("ASK")) of the Group increased by 3.33% as compared with the same period last year (a year-on-year ("YoY") basis), of which, the passenger capacity for domestic routes decreased by 1.78% as compared with the same period last year, and the regional routes and international routes increased by 1.11% and 20.04%, respectively, as compared with the same period last year. Compared with the same period last year, passenger traffic (measured by revenue passenger kilometres ("RPK")) increased by 10.07%, of which, passenger traffic for domestic routes, regional routes and international routes increased by 3.44%, 7.45% and 32.50%, respectively, as compared with the same period last year. The passenger load factor was 84.55%, representing an increase of 5.17 percentage points as compared with the same period last year, of which, the passenger load factor for domestic routes, regional routes and international routes increased by 4.26, 4.49 and 8.02 percentage points, respectively, as compared with the same period last year.

In terms of cargo operations, in December 2024, cargo capacity (measured by available tonne kilometers ("**ATK**") - Cargo and Mail) decreased by 8.62% as compared with the same period last year. Cargo and mail traffic (measured by revenue tonne kilometres ("**RTK**") - Cargo and Mail) decreased by 2.05% as compared with the same period last year. The cargo and mail load factor was 55.89%, representing an increase of 3.75 percentage points as compared with the same period last year.

In December 2024, the Group has newly launched the following new major route: Beijing Daxing – Vientiane – Beijing Daxing (being seven flights a week).

In December 2024, the Group introduced eight aircrafts (including three A321NEO aircrafts, two A319NEO aircrafts, one A320NEO aircraft, one ARJ21 aircraft and one C919 aircraft), and disposed of ten aircrafts (including six A319 aircrafts, two E190 aircrafts, one A332 aircraft and one A321 aircraft). As of the end of December 2024, the Group operated a fleet of 917 commercial aircrafts as set out below:
